RULES AN	ND REGULATIONS

The lot owner agrees to become a Member of the Association by purchasing a part-ownership of the Association's properties in return either for a cash payment of \$125.00 or for proof by the lot owner that a former owner of this same lot had paid a "tap-on" fee or Membership Fee.

The Association agrees to provide, at no expense to the Member, a water connection from its mains to the boundary of the above-mentioned lot at the time that the Member requires water for domestic use.

The Member agrees that he will permit no person other than a plumber approved by the Association to install a water line or otherwise tamper with the Association's mains which may be within the boundaries of his lot.

So long as he does not have a water connection to the Association's mains, but the mains lie either in front of or adjacent to his lot, the lot owner agrees to pay a monthly Inactive Membership dues of \$1.20 as a means of assuring that an adequate supply of water will be available for future needs.

After the Member begins to receive water, he agrees to pay an Active Membership dues of \$6.00 per month for each open connection which provides for the cost of supplying water and for present and future needs of the Association's Water Circulation Program.

A 10% penalty charge will be added to any bill of the unpaid balance that remains unpaid for more than 30 days.

PUBLIC SERVICE COMMISSION

The Association has the right to enter upon the Member's premises to inspect for leaks or other reasonable purpose.

The water connection to the Association's mains may be disconnected at the Member's expense for non-payment of dues after a period of 4 months. Notice will be sent by Registered mail to the member after the third month. In case of hardship, the Executive Committee will allow budget payments until hardship ceases.

As a Member of the Association, the lot owner will be entitled to voting rights of all matters as long as he is in good standing with the Association.

All water connections must be no greater than 3/4 inch inside diameter and no other pipe shall be used other than that approved by FHA.
