**RULES AND REGULATIONS**

1. Rules and regulations for the government of water utility which may be adopted by the Public Service Commission of Kentucky, and all amendments thereto and modifications thereof, which may be made by said Commission.
2. All bills are due and payable on the 10th of the following month after billing. In the event the bill is not paid on or before the 10th of the said month, 10% shall be added to the bill.
3. A charge of \$1.00 shall be made for turning water on when water has been turned off for non-payment of bill.
4. For all new customers, there shall be an original tap-on fee of \$150.00.

RULES AND REGULATIONS

Pilot Oak Water Supply, e/o Mr. J. T. Hedge, Route 1, Box 91A, Water Valley, Kentucky 42085 shall furnish unmetered water to approximately 48 present users and to other future users who desire this service for a monthly rate of \$7.00 plus applicable taxes beginning December 1, 1982. This rate shall remain in effect until such time as the Kentucky Public Service Commission shall authorize a change in this rate.

Pilot Oak Water Supply shall supply this water to all subscribers and shall maintain well, pumping equipment, water lines, etc. up to the subscribers tap on location. No maintenance or service shall be performed by Pilot Oak Water supply on any supply lines or equipment installed and/or owned by the various subscribers or users.
