	RULES AND REGULATIONS

#### I. DEPOSIT

All customers connected or reconnected after July 1, 1981 shall deposit with the ROY POTTER WATER SERVICE the sum of two-twelfths (2/12) of the estimated annual bill, "shich shall be refunded along with interest at the rate of 6% per annum when customer is disconnected and all debts owing said water service have been satisfied.

#### **II. DISCONTINUANCE OF SERVICE**

The utility may refuse or discontinue service to an applicant or customer, after proper notice, for failure to comply with its rules and regulations or state and local government rules and regulations , when a costomer or applicant refuses or neglects to provide reasonable access to the premises, for fraudulent or illegal use of service , or for nonpayment of bills. If discontinuance is for nonpayment of bills , the customer shall be given at least forty-eight (48) hours written notice, separate from the original bill, and cut-off shall be effected not less than twenty (20) days after the mailing date of the original bill unless , prior to discontinuance , a residential customer presents to the utility a written certificate , signed by a physician, Registered nurse , or public health officer , that such discontinuance will aggravate an existing illness or infirmity on the affected premises , in which case discontinuance may not be effected until the affected resident can make other living arrangements or until not less than ten (10 ) days elapse from the date of the Utility's notification. When Ea Colongerous condition is found to exist on the customer's or applicant's premises, the service shall be cut off without notice or refused.

#### III. EXTENSION OF SERVICE

4 1982 RATES AND TARIFFS

Water service shall be extended up to fifty feet to the property line of any residential customer within the service area of said water service, when all deposits have been paid and all rules and regulations complied with. Water service maybe extended more than fifty feet with a satisfactory agreement for payment by customer of the water service actual cost for the additional extension. Refunds shall be made to said customer for a period not to exceed ten (10) years, as provided in 807 KAR 5:066E, Section 12(2).

### 1V. RECONNECTION OF SERVICE

Any customer who has been forcibaly or voluntarily disconnected may be reconnected upon payment of the normal deposit, plus a \$ 22.00 reconnection fee as listed in Attachment A, "Special Charge Cost Schedule".

## V. BILLING PROCEDURE

Monthly bills shall be mailed or hand delivered to customers the first of each month, and are payable in advance of the current month. All bills become delinquent on the 20th. day of the current month.

### VI. LATE PAYMENT PENALTY

All bills not paid by the 20th of each month are subject to a penalty of ten percent ( 10%) which amount shall be added to said bill.
