**RULES AND REGULATIONS**

The following rules and regulations are subject to change by the Commission at any time.

1. Meters will be read monthly between the 1st and 5th of each month.
2. Bills will be dated and mailed between the 5th and 7th day of each month. Said bills will state that they are to be paid by the 20th day of that month. However, provisions contained in the rate regulation as to penalties and cut-offs will apply.
3. If bills are evaded meter will be removed and an instalation fee of \$10.00 plus payment of back bills will be required before meter is replaced.
4. Complaints may be made to the operator of the system.
5. The principal place of business of the district will be Julia Smith's, Rt. 1, Box 20-E, Jackson, Kentucky.
6. Water bills may be paid to Julia Smith, Rt. 1, Box 20-E, Jackson, Kentucky.
