These rules and regulations are intended to supplement all Bond Resolutions and By-laws which have been enacted by the District and which are incorporated by reference.				

- 2. All bills shall be rendered monthly and shall be due and payable on the 1st of the following month. Bills shall be dated as of the meter reading date. Bills become delinquent on the 11th of the month and a 10% penalty will be added. A delinquent notice will be mailed on the 12th of each month and such notice will state that service shall be discontinued if not paid within a 30 day period from the date of said bill. If not paid in the 30 day period, a pull notice will be sent out by a collector and a \$5.00 service will be added.
- The District reserves the right to require a security deposit not to exceed 2/12 of the customers estimated annual bill. Interest shallbe paid on deposit so held at the rate of 6% per annum accuring from date of deposit.
- Complaints may be made to the office of the District, 104 West Maple St., Nicholasville, Ky. 40356, and be appealed to the Board within 10 days.
- Each house must be metered separately and the customer cannot
- give away or resell water without consent of the District.

The District shall permit main line extensions according to the ervice Commission provisions of Title 807 KAR 5:066 Section 12. No residence shall be served through a field connection. 7.

The District shall maintain not less than 30 p s i g under normal 8.
