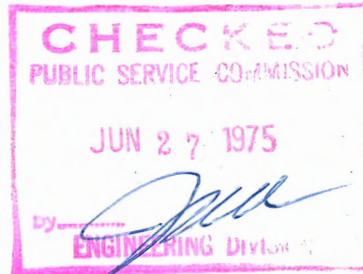

Special Rules (Cont'd):

The charge also applies if service is reinstalled after it has been disconnected for non-payment of bills, violation of the company's or Commission's rules and regulations, and the customer has qualified for and requested the service to be reconnected.

In addition to this a deposit of \$20.00 will be required to secure payment of bill. All fees to be paid in advance. If service is provided 12 months at the same location any installation fees in excess of the \$20.00 deposit will be refunded.

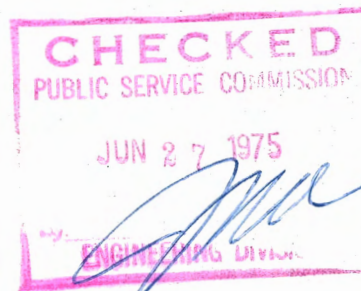
