The original and three (3) copies of this letter are submitted on behalf of ITI Inmate Telephone, Inc. to request immediate cancellation of its Certificate of Authority to operate as a reseller of interexchange telephone service in the state of Kentucky. The company provided automated operator assisted services to inmates and other incarcerated persons in correctional facilities and had no presubscribed customers. Therefore, no customer notice was required.

ITI recently sold all of its telecommunications assets to DSI-ITI, LLC. The Commission was informed of this transaction by letter dated April 1, 2010. This company is no longer operational and will be dissolved in the very near future.
