I've pulled the January 27, 2020 withdrawal notice filed with Kentucky Secretary of State and will use that date as the official inactive date in the records of the Kentucky Public Service Commission. Our Executive Director has indicated it is not appropriate to void assessment as NetDiverse did not provide us a timely notice of status and the revenue was certified on June 1 to the Kentucky Department of Revenue. Any other related information (including Relay Tax) will be eliminated when the record for NetDiverse is made inactive in our records, which will occur by COB today.

It's no problem at all. I've not been able to locate a notice having been filed with us requesting withdrawal of authority to operate. The assessment you received was related to the Gross Report filed with us March 27, 2020 providing an assessable revenue figure of \$528.82 for calendar year 2019. You may submit proper documentation via email to our Executive Director at PSCED@ky.gov request to withdraw. I'm unsure if it's possible to get the assessment voided as that figure was certified on June 1 to the Kentucky Department of Revenue based on the March submission. At the least, you submitting proper notice with us would get you off the requirement list for next year though.
