## SECTION 1 - TECHNICAL TERMS AND ABBREVIATIONS

Access Line - An arrangement from a local exchange telephone company or other common carrier, using either dedicated or switched access, which connects a Customer's location to TNCII's location or switching center.

Authorization Code - A numerical code, one or more of which may be assigned to a Customer, to enable TNCII to identify the origin of the Customer so it may rate and bill the call. Automatic number identification (ANI) is used as the authorization code wherever possible.

<u>Commission</u> - Used throughout this tariff to mean the Kentucky Public Service Commission.

Customer - The person, firm, corporation or other legal entity which orders the services of TNCII or purchases a TNCII Prepaid Calling Card and/or originates prepaid calls using such cards, and is responsible for the payment of charges and for compliance with the Company's tariff regulations.

<u>Company or TNCII</u> - Used throughout this tariff to mean Trans National Communications International, Inc., a Delaware corporation.

<u>Dedicated Access</u> - The Customer gains entry to the Company's services by a direct path from the Customer's location to the Company's point of presence.

Holiday - New Year's Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day. Holidays shall be billed at the evening rate from 8 a.m. to 11 p.m. After 11 p.m., the lower night rate shall go into effect.

Prepaid Calling Card A card issued by the Company, containing an Authorization Code which identifies a specific Prepaid Account of Telecom Units, which enables calls to be processed, account activity to be logged, and balances to be maintained, on a prepayment basis.

Resp. Org - Responsible Organization or entity identified by an 800 service Customer that manages and administers records in the 800 database and management system.

<u>Switched Access</u> - The Customer gains entry to the Company's services by a transmission line that is switched through the local exchange carrier to meach the Company's point of presence.

Telecom Unit - A measurement of telecommunications service equivalent to one minute of usage between any two points within the Commonwealth of Kentucky.

Telecommunications - The transmission of voice communications or, subject to the transmission capabilities of the services, the transmission of data, facsimile, signaling, metering, or other similar communications.

<u>Underlying Carrier</u> - The telecommunications carrier whose network facilities provide the technical capability and capacity necessary for the transmission and reception of Customer telecommunications traffic

# SECTION 2 RULES AND REGULATIONS

#### 2.1 Undertaking of the Company

This tariff contains the regulations and rates applicable to in rastate resale telecommunications services provided by TNCII for telecommunications between points within the Commonwealth of Kentucky. Resale services are furnished subject to the availability of facilities and subject to the terms and conditions of this tariff in compliance with limitations set forth in the Commission's rules. Company's services are provided on a statewide basis and are not intended to be limited geographically. Company offers service to all those who desire to purchase service from the Company consistent with all of the provisions of this tariff. Customers interested in the Company's services shall file a service application with the Company which fully identifies the Customer, the services requested and other information requested by the Company. The Company reserves the right to examine the credit record and check the references of al applicants and Customers. The Company may examine the credit profile/record of any applicant prior to accepting the service order. The service application shall not obligate the Company to provide services or to continue to provide service if a later check of applicant's credit record is, in the opinion of the Company, contrary to the best interest of the Company. The Company may act as the Customer's agent for ordering access connection facilities provided by other carriers or entities when authorized by the Customer, to allow connection of a Customer's location to a service provided by the Company. - 2.1.1 The services provided by TNCII are not part of a joint undertaking with any other entity providing telecommunications channels, facilities, or services, but may involve the resale of the Message Toll Services (MTS) and Wide Area Telecommunications Services (WATS) of underlying common carriers subject to the jurisdiction of this Commission.
- The rames and regulations contained in this tariff apply only to the resale services furnished by TNCII and do not apply, unless otherwise specified, to the lines, facilities, or services provided by a local exchange telephone company or other common carriers for use in accessing the services of TNCII.
- 2.1.3 The Company reserves the right to discontinue furnishing services, or limit the use of service necessitated by conditions beyond its control, including, without limitation: lack of satellite or other transmission medium capacity; the revision, alteration or repricing of the Underlying Carrier's tariffed offerings; or when the use of service becomes or is in violation of the law or the provisions of this tariff.

#### 2.2 Use of Services

2.2.1 TNCII's services may be used for any lawful purpose consistent with the transmission and FUBLIC SERVICE COMMISSIONSWITCHING parameters of the telecommunications facilities utilized in the provision of services, subject to any limitations set forth in this Section 2.2.

- 2.2.3 The use of TNCII's services without payment for service or attempting to avoid payment for service by fraudulent means or devices, schemes, false or invalid numbers, or false calling or credit cards is prohibited.
- 2.2.4 TNCII's services are available for use 24 hours per day, seven days per week.
- TNCII does not transmit messages, but the 2.2.5 services may be used for that purpose.
- TNCII's services may be denied for nonpayment 2.2.6 of charges or for other violations of this tariff.
- Customers shall not use the service provided 2.2.7 under this tariff for any unlawful purpose.
- The Customer is responsible for notifying the 2.2.8 Company immediately of any unauthorized use of services.

#### Liability of the Company 2.3

The Company shall not be liable for any 2.3.1 claim, loss, expense or damage for any interruption, delay, error, omission, or defect in any service, facility or transmission provided under this tariff, if caused by the Underlying Carrier, an act of God, fire, war, civil disturbance, act of government, or due to any other causes beyond the Company's control. Acceptance of the PUBLIC SERVICE COMMISSIONLiability provisions contained in this tariff by the Commission does not constitute its

#### 2.4 Responsibilities of the Customer

- 2.4.1 The Customer is responsible for placing any necessary orders and complying with tariff regulations. The Customer is also responsible for the payment of charges for services provided under this tariff.
- 2.4.2 The Customer is responsible for charges incurred for special construction and/or special facilities which the Customer requests and which are ordered by TNCII on the Customer's behalf.
- 2.4.3 If required for the provision of TNCII's services, the Customer must provide any equipment space, supporting structure, conduit and electrical power without charge to TNCII.

- 2.4.5 The Customer shall cause the temperature and relative humidity in the equipment space provided by Customer for the installation of TNCII's equipment to be maintained within the range normally provided for the operation of microcomputers.
- The Customer shall ensure that the equipment 2.4.6 and/or system is properly interfaced with TNCII's facilities or services, that the signals emitted into TNCII's network are of the proper mode, bandwidth, power and signal level for the intended use of the subscriber and in compliance with criteria set forth in this tariff and that the signals do not damage equipment, injure personnel, or degrade service to other Customers. If the Federal Communications Commission or some other appropriate certifying body certifies terminal equipment as being technically acceptable for direct electrical connection with interstate communications service, TNCII will permit such equipment to be connected with its channels without the use of protective interface devices. If the Customer fails to maintain the equipment and/or the system properly, with resulting imminent harm to TNCII equipment, personnel or the quality of service to other Customers, TNCII may, upon written notice, require the use of protective equipment at the Customer's expense. If this fails to produce satisfactory quality and safety, TNCII may, upon written notice, terminate the Customer's service.

- 2.5.3 Service may be discontinued by TNCII without notice to the Customer, by blocking traffic to certain countries, cities or NXX exchanges, or by blocking calls using certain Customer authorization codes, when TNCII deems it necessary to take such action to prevent unlawful use of its service. TNCII will restore service as soon as it can be provided withous undue risk, and will, upon request by the Customer affected, assign a new authorization code to replace the one that has been deactivated.
- 2.5.4 The Customer may terminate service upon thirty
  (30) days written notice for the Company's standard month to month contract. Customer will be liable for all usage on any of the Company's service offerings until the Customer actually leaves the service. Customers will continue to have Company usage until the Customer notifies its local exchange carrier and changes its long distance carrier. - Service is provided and billed on a billing 2.10.1 cycle basis, beginning on the date that service becomes effective. Billing is payable upon receip:.
- The customer is responsible for payment of all 2.10.2 charges for services furnished to the Customer, as well as to all persons using the Customer's codes, exchange lines, facilities, or equipment, with or without the knowledge or consent of the Customer. The security of the Customer's Authorization Codes, presubscribed exchange lines, and direct connect facilities is the responsibility of the Customer. All calls placed using direct connect facilities, presubscribed exchange lines, or Authorization Codes will be billed to and must be paid by the Customer. Recurring charges and non-recurring charge: are billed in advance. The initial billing may, at Company's option, also include one month's estimated usage billed in advance. Thereafter, charges based on actual usage during a month and any accrued interest will be billed monthly in arrears.
- All bills are presumed accurate, and shall be 2.10.3 binding on the customer unless objection is received by the Company in writing within 30 days alter such bills are rendered. No credits, refunds, or adjustments shall be granted if demand therefore is not received by the Company in writing, in period telephone within such 30 day period.

#### 2.11 Collection Costs

In the event Company is required to initiate legal proceedings to collect any amounts due to Company for regulated or non-regulated services, equipment or facilities, or to enforce any judgment obtained against a Customer, or for the enforcement of any other provision of this tariff or applicable law, Customer shall, in addition to all amounts due, be liable to Company for all reasonable costs incurred by Company in such proceedings and enforcement actions, including reasonable attorneys' fees, collection agency fees or payments, and court costs. In any such proceeding, the amount of collection costs, including attorneys' fees, due to the Company, will be determined by the court.

#### 2.12 <u>Taxes</u>

All federal, state and local taxes, assessments, surcharges, or fees, including sales taxes, use taxes, gross receipts taxes, and municipal utilities taxes, are billed as separate line items and are not included in the rates quoted herein.

#### 2.13 Late Charge

A one time late fee of 1.5% monthly or the amount otherwise authorized by law, whichever is lower, will be charged on any past due balances of more than 30 days.

#### 2.14 Returned Check Charge

A fee, as set forth in the Rates section herein, will be charged whenever a check or draft presented for payment for service is not accepted by the institution on which it is written.

#### SECTION 3 - DESCRIPTION OF SERVICE

#### 3.1 Computation of Charges

- The total charge for each completed call may be a variable measured charge dependent on the duration, distance and time of day of the call. The total charge for each completed call may also be dependent only on the duration of the call, i.e. a statewide flat rate per minute charge. The variable measured charge is specified as a rate per minute which is applied to each minute. All calls are measured in increments as set forth in the Rates Section of this tariff. 3.5.2 Travel Cards

#### 3.5.4 TNCII Prepaid Calling Cards

This service permits use of Prepaid Calling Cards for placing long distance calls. Customers may purchase TNCII Prepaid Calling Cards at a variety of retail outlets or through other distribution channels. TNCII Prepaid Calling Cards are available at a variety of face values. TNCII Prepaid Calling Card service is accessed using the TNCII toll-free number printed on the card. The caller is prompted by an automated voice response system to enter his/her Authorization Code, and then to enter the terminating telephone number. TNCII's processor tracks the call duration on a real time basis to determine the number of Telecon Units consumed. The total consumed Telecon Units for each call is deducted from the remaining Telecom Unit balance on the Customer's TNCII Prepaid Calling Card.

All calls must be charged against Prepaid Calling Card that has a sufficient Telecom Unit balance. A Customer's call will be interrupted with an announcement when the balance is about to be depleted.

In order to continue the call, the Customer can either call the toll-free number on the back of the TNCII Prepaid Calling Card and "recharge" the balance on the card using a nationally recognized credit card, or the Customer can throw the card away and purchase a new one. Calls in progress will be terminated by the Company if the balance on the TNCII Prepaid Calling Card is insufficient to continue the call and the Customer fails to enter the number of another valid TNCII Prepaid Calling Card prior to termination.
