Special Service for Trailer Parks

Connection fee with 1½" meter, \$2,000.00; 2" meter,
\$2,500.00.

The trailer park owner or operator has the option of
constructing its own distribution lines within the
trailer park and purchasing water on the following
basis:

First	50,000 Gallons	\$48.75 Minimum
All Over	50,000 Gallons	0.65 per 1,000 Gal.

OR THE FOLLOWING RATE SCHEDULE:

The number of trailers is defined as the total number of
trailers in the Trailer Park multiplied by 80%. For a
trailer park of 50 trailers the owner would pay a minimum
monthly bill of .8 x 50 = 40 trailers x 4.50 per month each
or a total of \$180.00 per month. In other words the
trailer park owner would pay minimums on the basis of 80%
of the trailers in the park whether they were occupied or
not.

The association would build the water distribution lines to
each trailer space and install a single meter to serve the
trailer park. The trailer park owner would construct the
service line to each individual trailer. A 1½" meter would
be used for a park of 50 trailers or less. A park over 50
trailers would require a 2" meter.

The minimum bill will include 2,000 gallons per trailer,
all water in excess of the minimum bill would be billed
at the rate of 85 cents per 1,000 gallons.

CLASSIFICATION OF SERVICE

The following rules and regulations are subject to change by the Board of Directors at any time subject to approval by the Public Service Commission.

1. Meters will be read monthly between the 25th and 30th of each month.
2. Bills will be dated and mailed on the first of each month. Said bills will state that they are to be paid within 10 days.
3. All meters will be located on district mains and in the absence of special permission on the property to be served.
4. Complaints may be made to the operator of the system and may be appealed to the Board of Directors.
5. The principal place of business of the District will be the home of James Benton Battaile, Sr., Combs Ferry Road, Winchester, Kentucky.
6. Water bills may be paid at the home of James B. Battaile, Combs Ferry Road, Winchester, Kentucky.
7. If bills plus penalty are not paid within 30 days, water service to such delinquent may be discontinued and not restored until all charges are paid, including a disconnection and reconnection charge of \$25.00.
8. Rates and charges shall be billed to owner of premises unless tenant has obtained prior approval.
