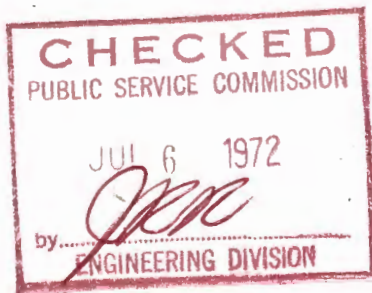

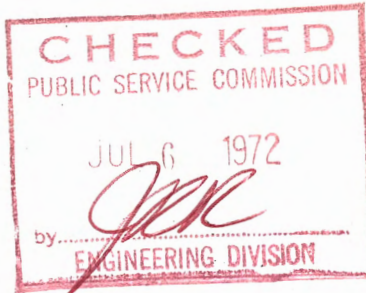

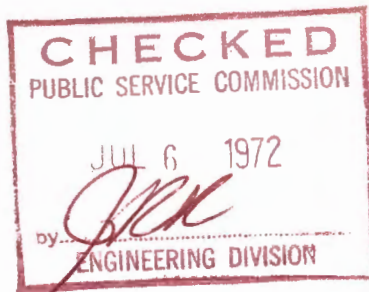

RULES AND REGULATIONS

THE FOLLOWING RULES AND REGULATIONS ARE SUBJECT TO CHANGE BY THE WATER DISTRICT COMMISSIONERS AT ANY TIME SUBJECT TO APPROVAL BY THE PUBLIC SERVICE COMMISSION.

1. METERS WILL BE READ MONTHLY BETWEEN THE 1<sup>ST</sup> & 5<sup>TH</sup> OF EACH MONTH.
2. BILLS WILL BE DATED AND MAILED ON THE 15<sup>TH</sup> OF EACH MONTH. SAID BILLS WILL STATE THAT THEY ARE TO BE PAID ON OR BEFORE THE 15<sup>TH</sup> OF THE FOLLOWING MONTH.
3. THE PRINCIPAL PLACE OF BUSINESS OF THE DISTRICT WILL BE THE KENTON STATION GOLF COURSE CLUB HOUSE, MAYSVILLE, KENTUCKY.
4. WATER BILLS MAY BE MAILED OR PAID AT THE KENTON STATION GOLF COURSE, R.R. #2, MAYSVILLE, Ky.
