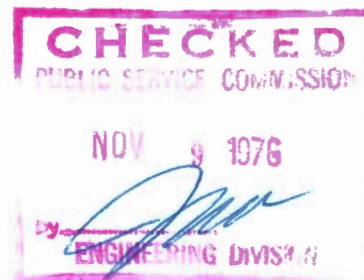
RULES AND REGULATIONS

1. The individual residential owner shall be responsible for the construction and maintenance of the service line which will extend from their residence to the main and effluent line which shall be installed by Robert A. Jones.
2. All rate payments shall be made to the Oldham County Water District Office No. 3, said payments to be made either by cash delivery or mailing to its address.
3. Robert A. Jones, or his authorized agent or representative, shall have the right to go upon the individual residential owner's property for the purpose of laying, maintaining and servicing the main effluent line. Robert A. Jones, or his authorized agent or representative, shall further have the right to go upon the individual residential owner's premises to disconnect the property from the main effluent line should the individual residential owner fail to pay the herein described rates.
