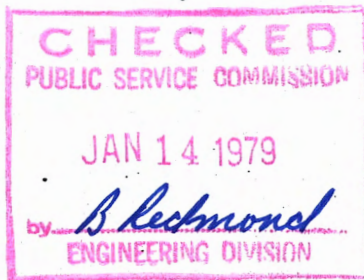

The following rules and regulations are subject to change by the water association commissioners at any time subject to approval by the PUBLIC SERVICE COMMISSION.

1. Meters will be read monthly between the 5<sup>th</sup> and the 10<sup>th</sup> of each month.
2. Bills will be dated and mailed on the 1<sup>st</sup> of each month. Said bills state that they are to be paid within 15 days.
3. All meters will be located on ~~district~~<sup>association</sup> mains, and in the absence of special permission on the property to be served.
4. Complaints may be made to the sec. & Treas, or to any association commissioner.
5. The principal place of business of the Association will be at Michael C. Bastin's residence, Rt # 1, Box 215, Hustonville, Ky, 40437.
6. Water bills may be paid at this residence or mailed to McKinney Water Assoc., INC., Box 188, McKinney, Ky. 40348
