**RULES AND REGULATIONS**

**CONNECTION FEES**

<u>5</u> / <u>8</u> or 3/4" Connection to be paid in Advance	\$200.00
1 " Connection to be paid in Advance	\$260.00
2" Connection to be Paid in Advance	\$360.00
6" Non Metered Fire Hydrant Approx.	\$450.00

1. If main is not in front of customer wanting water, the district will lay 50' main free, the balance to be paid in advance plus connection fee.
2. Customers wanting water in rental units shall pay a deposit of \$10.00. Same to be refunded when customers discontinue use of water.
3. Customers that put a trailer on their premises and connect to existing meter connection to main house shall pay two minimum fees, plus water used as per established rates.
4. New Commercial trailer courts shall pay minimum of four bills plus water used and one additional nper each unit added, based on 5/8" minimum.
5. To turn on water after having been turned off for non payment, a charge of \$10.00 plus old account shall be paid. Water to be turned off after d 60 days deliquency.
6. The customer shall not sell or give away water.
7. Cost of fire plugs shall be paid by city or customers having same installed, and shall pay \$50,00 maintenance per year for plug.
8. The customer installing water service shall comply with Kentucky State Plumbing Code.

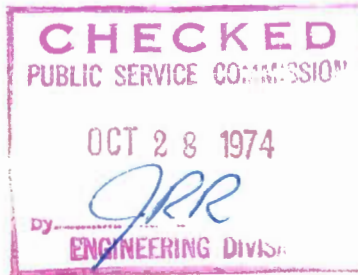
RULES AND REGULATIONS

NO.15 FIRE HYDRANTS IN UNINCORPORATED AREAS:

(N)

Pulaski County Water District No.1 Will install fire hydrants in an unincorporated area in the County where distribution mains are adequate for fire protection subject to the following requirements;

- (A) A written request by the majority of the water customers to be served by said hydrant is **required**.
- (B) Where it is evident that a credit rating will be given on the Insurance Premiums after the installation of the Hydrant.
- (C) Fire hydrant location will be determined by the Commissioners in a manner to provide the greatest fire protection for water Customers within the hydrant area.
- (D) Fire hydrant service charges shall be added to each water Customer's bill where the property is within 1,000 feet of fire hydrant location, The 1,000 feet shall be measured from the fire hydrant along the center line of existing and passable roads, and, or driveways.
- (E) A charge of 50¢ per month for all water customers within 1,000 feet of hydrant location.
- (F) Water service shall be discontinued for failure to pay hydrant service charge.
