Meters are read on the 13th and 14th of the month, unless this happens to fall on the weekend. Bills are mailed by the 16th of the month.

All bills not paid by the 10th of the following month are subject to a 10% penalty. Service will be discontinued if not paid in 45 days. Water turned off for non-payment, will be charged \$1.00 for turning water back on.

Water Tap on Fee is \$400.00. This included

Meter, Meter Box, Meter box cover, tubing, casings, and cut-off.

Sewer Tap on Fee is \$350.00 where sewer line is available.
