RULES AND REGULATIONS

BARDSTOWN WATER ASSOCIATION

The failure of a member to pay water charges duly imposed, shall result in the automatic imposition of the following penalties:

- A. Non-payment within ten days from the due date will be subject to a penalty of ten per cent of the delinquent account.
- B. Non-payment within thirty days from the due date will result in the water being shut off from the member's property.
- C. Non-payment for sixty days after original due date will allow the corporation, in addition to all other rights and remedies to purchase the member's Membership Certificate and terminate his membership and in such event the member shall not be entitled to receive, nor the corporation obligated to supply, any water under this agreement.
- D. In the event it becomes necessary for the corporation to shut off the water from a member's property, a fee of \$15.00 will be charged for a reconnection of the service.
