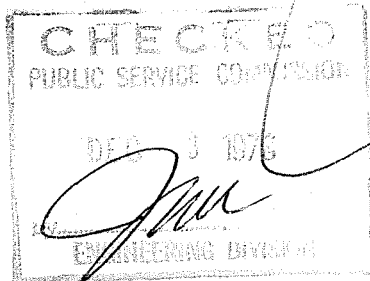

<p>1. <u>APPLICABLE:</u> In all territory served by Cooperative's transmission system.</p> <p>2. <u>AVAILABILITY OF SERVICE:</u> Available only for service to member rural electric cooperatives, subject to the special terms and conditions hereinafter set forth and to such of Cooperative's general rules and regulations on file with the Public Service Commission of Kentucky.</p> <p>3. <u>RATE SCHEDULE:</u> A. <u>Monthly Delivery Point Rate:</u> (1) <u>Demand charge of:</u> All KW of billing demand at \$3.40 per kilowatt (2) <u>Plus an energy charge of:</u> All KWH per month at 8.64 mills per KWH for all KWH sold on and after June 20, 1977, plus a surcharge of .322 mills per KWH for all KWH sold on and after July 1, 1977, for the specific purpose of amortizing the ten year loan from the Louisville Bank for Cooperatives, this surcharge of .322 mills per KWH to continue until said debt is paid. The total energy charge will be 8.962 mills per KWH until such debt is paid and 8.64 mills thereafter.</p> B. <u>Fuel Clause:</u> The energy charge shall be increased or decreased by a fuel adjustment factor as follows: $\frac{F + PP}{S} \text{ minus } .008163$

The cost of fuel shall include no items other than those listed in Account 151 and transferred to Account 501 of the Uniform System of Accounts.


(T) PP = Dollar cost of purchased power excluding HMP&L Station II less the cost of purchased power devoted to inter-system sales.

S = All kilowatt hour sales excluding inter-system sales.

To facilitate the prompt mailing of bills, the fuel adjustment amount for any billing month shall be the product of the "Adjustment Factor" for the preceding month as defined above and the kilowatt hours consumed by the Member in the preceding month.

4. MINIMUM BILL:

(T)(I) The minimum monthly bill shall not be less than \$3.40 per kilowatt of Billing Demand.
