All wiring, pole lines, and other equipment, except metering equipment, on the load side of the delivery point shall be owned and maintained by the member.

<u>TERMS OF PAYMENT</u>: The above rates are net, the gross being five percent (5%) higher. In the event the current monthly bill is not paid within twelve (12) days from the date the bill was rendered, the prompt payment discount shall be forfeited and the gross amount shall apply.
