

AMENDMENT TO ELECTRIC SERVICE AGREEMENT

THIS AMENDMENT TO ELECTRIC SERVICE AGREEMENT by and between **KENERGY CORP.**, a Kentucky corporation, 6402 Corydon Road, Henderson, KY, 42420 ("Seller") and **ARMSTRONG COAL COMPANY, INC.**, 407 Brown Road, Madisonville, KY 42431 ("Consumer"). The Seller and Buyer are collectively referred to as the "Parties." The terms, covenants, and conditions set forth herein are intended to and shall have the same force and effect as if set forth at length in the body of the Electric Service Agreement.

WHEREAS, Kenergy Corp. is the retail electric supplier to Armstrong;

WHEREAS, Consumer entered into an Electric Service Agreement with Seller dated September 27, 2010, and effective November 1, 2010; and

WHEREAS, Seller and Consumer wish to amend the terms of the Assumption Agreement;

NOW, THEREFORE, in consideration of the mutual agreements, covenants and other promises set forth herein, the mutual benefits to be gained by the performance thereof, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and accepted, the Parties agree as follows:

1. Consumer's maximum contract demand shall be 3,500 kW and the minimum contract demand for billing purposes shall be 2,100 kW for any billing period.
2. Defined terms used herein shall have the same meaning defined in the Agreement.
3. Other than as set forth herein, the Agreement shall remain unamended and in full force and effect.
4. This Amendment shall not become effective until accepted or otherwise approved in writing by the Kentucky Public Service Commission, and until the wholesale agreement between Seller and Big Rivers Electric Corporation is approved by Rural Utilities Service, whichever is later.
5. In all other respects the terms and provisions of the aforementioned electric service agreement, as amended, are adopted and reaffirmed.


