Single-phase at available voltage.

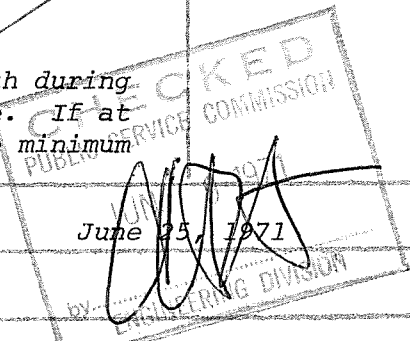

First	25 KWH or less per month	\$3.00 per month Minimum Bill
Next	25 KWH per month	@.05 per KWH
Next	50 KWH per month	@.04 per KWH
Next	100 KWH per month	@.03 per KWH
Next	300 KWH per month	@.02 per KWH
Over	500 KWH per month	@.015 per KWH

MINIMUM CHARGES

The minimum annual charge under the above rate shall be \$36.00 where 5 KVA or less of transformer capacity is required. For consumers requiring more than 5 KVA of transformer capacity, the minimum annual charge shall be increased at the rate of \$9.00 for each additional KVA or fraction thereof required, in which event, a corresponding amount of additional energy shall be included in accordance with the foregoing rate.

Bills for actual usage shall be rendered each month during which energy is used without regard to monthly minimum charge. If at the end of twelve months, the total charges are less than the minimum
