<p align="center">EXPERIMENTAL RESIDENTIAL SERVICE - TIME-OF-DAY</p> <p>AVAILABILITY OF SERVICE Available for a period of limited to two years, as an experimental tariff to consumers eligible for <u>Tariff Farm and Home Service T-O-D</u> is for the purpose of conducting a time-of-day rate experiment designed to provide data to evaluate the cost and benefits of time-of-day pricing and its effect on the use of electricity by residential consumers in the Cooperative's service area. Consumers who will be eligible for this tariff will be selected by the Cooperative and will agree voluntarily to participate in the Cooperative's residential time-of-day rate experiment.</p> <p>This tariff is limited to the consumers selected by the Cooperative and will require the installation of a special meter capable of registering the on-peak and off-peak kilowatt-hours.</p> <p>This tariff is available for single-phase service only.</p>

<p>FARM AND HOME SERVICE T-O-D SCHEDULE A-5-T-O-D (Con't)</p> <p>MINIMUM CHARGE The minimum monthly charge under the above rate shall be \$6.33 where 25 KVA or less transformer capacity is required. For members requiring more than 25 KVA transformer capacity, the minimum monthly charge shall be increased at the rate of \$.75 of each additional KVA or fraction thereof required. Payment of the minimum charge shall entitle the member in all cases to the use of the number of kilowatt hours, corresponding to the minimum charge in accordance with the foregoing rate.</p> <p>TERM OF PAYMENT The above rates are net, the gross being five percent (5%) higher. In the event the current monthly bill is not paid within 15 days from date of the bill, the gross rates shall apply.</p> <p>*FUEL ADJUSTMENT CLAUSE The above rate may be increased or decreased by an amount per KWH equal to the fuel adjustment amount per KWH as billed by the Wholesale Power Supplier plus an allowance for line losses.
