RE: Electronic Application of Louisville Gas and Electric Company for an Adjustment of its Electric and Gas Rates, a Certificate of Public Convenience and Necessity to Deploy Advanced Metering Infrastructure, Approval of Certain Regulatory and Accounting Treatments, and Establishment of a One-Year Surcredit Case No. 2020-00350

Dear Mr. Horrell:

On November 25, 2020, Louisville Gas and Electric Company ("LG&E") filed an application with the Kentucky Public Service Commission ("Commission") for approval of adjustments to its gas and electric rates, terms, and conditions including the rates for electric service under the power contract dated October 10, 1961, and amendments thereto between LG&E and Louisville Water Company.

On April 19, 2021, LG&E filed a Stipulation and Recommendation with the Commission proposing rates lower than those originally proposed in the Application dated November 25, 2020. On June 30, 2021, after evidentiary hearings, the Commission issued an Order approving the Stipulation with modifications.

The revisions applicable to electric service under the power contract dated October 10, 1961, between LG&E and Louisville Water Company, are set forth below:
