## RE: AN EXAMINATION OF THE APPLICATION OF THE ENVIRONMENTAL SURCHARGE MECHANISM OF LOUISVILLE GAS AND ELECTRIC COMPANY FOR THE TWO-YEAR BILLING PERIOD ENDING APRIL 30, 2015 - CASE NO. 2015-00222

Dear Mr. Horrell:

As a result of an Order issued in LG&E's Environmental Cost Recovery (ECR) Review in Case No. 2015-00222 dated December 7, 2015, the Kentucky Public Service Commission authorized a roll-in of a portion of the current ECR factor into existing base rates, including the rates contained in the power contract dated October 10, 1961 between the Louisville Water Company and LG&E. The roll-in results in an increase in demand charges effective with bills rendered on and after February 1, 2016.

The rates approved by the Commission to become effective with bills rendered on and after February 1, 2016, are set forth below:
