CONTRACT FOR ELECTRIC SERVICE

This contract and agreement made and entered into this $\frac{7^{th}}{T^{th}}$ day of <u>August</u>, 2006 by and between LOUISVILLE GAS AND ELECTRIC COMPANY ("Company") and <u>The Kroger Company #763</u> ("Customer").

WITNESSETH:

For a period of <u>One (1)</u> year(s), beginning <u>(see comment)</u>, or as soon as connection is made, and subject to the Company's general Terms and Conditions, Company will sell and deliver to Customer at <u>520 North 35th</u> <u>Street, Louisville, KY 40212</u>, and Customer will receive and pay for all electric service for the operation of <u>retail grocery store</u>. If Customer continues service after the expiration of the above period, this contract automatically will be renewed in accordance with the provisions of the applicable rate schedule. In consideration of Company's service to Customer's premises, Customer grants Company such rights across said premises as may be necessary to furnish service to neighboring premises. All electric capacity and energy taken under this agreement will be delivered as three phase, 60 cycle, alternating current of a nominal voltage of <u>277/480</u> volts at the point of delivery and metered as <u>Secondary</u> service.

This point of delivery requires an estimated system capacity of $\underline{468}$ KW on-peak and $\underline{468}$ KW off-peak, which results in a CONTRACT CAPACITY of $\underline{468}$ KW. Customer will give Company advance written notice, reasonable in relation to the magnitude of excess capacity desired but in no event less than 90 days, prior to any time Customer desires capacity in excess of Customer's CONTRACT CAPACITY set out above.

Each month Customer will pay to Company at its office for all capacity and energy delivered to Customer during the preceding billing period, determined in accordance with Rate Schedule <u>See Comments</u>.

COMMENTS:

Billing under this contract shall be provided under Rate Schedule STOD, Small Time-Of-Day Service, pending approval of the Public Service Commission of Kentucky. Customer is currently receiving service under Rate Schedule LC, Large Commercial Rate, should the Commission deny availability of STOD for this delivery point, billing will continue LC and this contract will be void.

TARIFF PROVISIONS

It is mutually agreed that the Company's general Terms and Conditions and rate applicable to the service supplied hereunder, as from time to time approved by and on file with the Public Service Commission of Kentucky, are made a part of this contract as fully as id written herein.
