RULES AND REGULATIONS AND CONDITIONS FOR SERVICE

1. Incorporated Terms. The terms and conditions of KRS 278.485, KAR 5:026 and any other applicable regulations, as they may be amended from time-to-time, are incorporated in this filing by reference. In addition to those incorporated terms and conditions, and not in limitation thereof, the following additional provisions apply and are a part of this filing.

2. General Terms.

(a) All gas sold and delivered under this Tariff shall be delivered at the varying pressures of the applicable pipeline of Jetta Operating Appalachia, LLC ("Jetta").

(b) It shall be the sole responsibility of the applicant, at applicant's sole cost, expense and risk, to supply and to have installed, inspected, and maintained the necessary regulator and equipment related thereto and all pipelines and other facilities beyond the tap on Jetta's pipeline, except for the meter which Jetta will install and own. In addition, it is the sole responsibility of the applicant to ensure that the gas in the applicant's pipeline contains a natural odorant, or is odorized, so that the gas is readily detectable by a person with a normal sense of smell. If the gas does not contain a natural odorant, the applicant must furnish, install, and maintain any odorization equipment necessary to comply with the odorization requirement contained in 807 KAR 5:026, Section 6(12). Such odorization equipment, if necessary, shall be installed in conformity with specifications approved by the Kentucky Public Service Commission ("Commission"). Gas may not be provided to the applicant prior to the approval by Commission Staff of the installation of the pipelines and equipment provided by applicant, including a

determination either that a natural odorant is present in the gas or that the requirement for artificial odorization by the applicant has been has been satisfied.

(c) Jetta shall not be liable to an applicant for any discontinuance, reduction, change or any other effect on service to the applicant resulting from: the plugging, shut-in, abandonment (temporary or final), or change in the use of any well or wells; temporary or permanent discontinuance or reduction of transportation of gas through any applicable pipeline; the use (or termination of use) of compressors or other equipment; breakage or maintenance of pipelines or other equipment; changes in Jetta’s operations; or other causes related to Jetta’s operations or business activities, any or all of which may be undertaken in Jetta’s sole discretion.

(d) Jetta is under no obligation to supply any specific quantity or quality of gas to an applicant. The applicant understands and acknowledges that the gas Jetta supplies is untreated; is not artificially odorized; may not be consistent in volume, Btu content or other qualities; and may have Btu content higher or lower than gas transported in interstate pipelines or supplied by gas distribution companies.

(e) Jetta shall have the right to enter upon the premises of the applicant to read, inspect, repair, change or remove the meter or any other equipment belonging to Jetta, and Jetta shall also have the right to reclaim any of its property which may be on the applicant’s premises.

(f) The applicant agrees that its acceptance and use of gas under this tariff shall be at the applicant’s sole risk, and Jetta shall not be liable to the applicant or any third person for any loss, damage to property, personal injury, loss of use, or any other claim of any kind arising from or associated with the applicant’s receipt or use of gas from Jetta or pipelines or other equipment or facilities associated with such receipt or use or any of the circumstances referenced in this Section 2.

4. CHANGE OF OWNERSHIP

In the event of a transfer of ownership of the premises being served pursuant to this tariff, Jetta will continue to make natural gas for domestic use available to the new owner pursuant to this tariff upon:

- (a) Payment of a deposit from the new owner equal to an estimated three months usage;
- (b) Payment of a \$25.00 turn-on fee if applicable;
- (c) Agreement by the new owner to the terms of this tariff.

5. GAS MEASUREMENT

(a) The measurement of gas by meter shall be conclusive upon the applicant and Jetta, unless the meter ceases to register, proves to be defective, or is found by test not to be accurate within the limitations of industry or regulatory standards. In such case, the consumption for the period in question shall be estimated. Jetta will, upon written application of applicant, have the meter removed, sealed and tested, and a certificate of the test will be given to the applicant. If the meter so tested shall be found to be accurate within the limits specified in the rules of the Commission, the applicant shall, upon presentation of a bill pay Jetta for such test.

(b) Where the service facilities or other equipment have been tampered with, resulting in improper measurement of the natural gas supplied, the applicant shall be required to pay for such quantity of natural gas as Jetta may estimate from available information to have been used but not

registered by Jetta's meter. In addition thereto, the applicant shall be required to bear all costs incurred by Jetta for investigations and inspections and for such protective equipment as may be necessary in Jetta's judgment.

(c) The applicant will promptly notify Jetta of any known or suspected gas leaks.

6. PAYMENT OF BILLS; OTHER DEFAULT; TERMINATION OF SERVICE

(a) The applicant shall pay the installation charge and deposit referred to above and, thereafter, pay Jetta for all gas delivered at rates approved by the Commission. Jetta shall render statements to the applicant at regular monthly intervals for gas delivered. For purposes of this Tariff, the term "month" shall mean the period between meter readings, which may or may not correspond to a calendar month or the duration of a calendar month.

(b) The applicant shall remit full and complete payment of each invoice within twenty (20) days following the applicant's receipt thereof. If the applicant fails to make such payment, Jetta will provide notice of the delinquency and that the applicant's access to natural gas pursuant to this tariff may be terminated for non-payment ten(10) days following the mailing of such notice but not before thirty-five (35) days after the mailing of the original bill.

(c) Jetta shall be entitled to terminate the applicant's access to natural gas pursuant to this tariff for any reason provided in the applicable statutes and regulations and as stated herein. Termination of service shall not be Jetta's sole remedy for the recovery of any amounts due hereunder, and Jetta shall have all remedies available to it at law or equity for any breach or failure by the applicant to abide by and perform its obligations under the terms of this tariff.
