

Amendment to Large Volume Natural Gas Service Agreement

This AMENDMENT dated October 11, 2025 | 4:43 AM PDT amends and modifies the Large Volume Natural Gas Service Agreement dated October 1, 2024, (the “Service Agreement”) between ATMOS ENERGY CORPORATION, a Texas and Virginia Corporation (“Atmos Energy”) and Owens-Brockway Glass Container Inc., a Delaware Corporation (“Customer”).

WITNESSETH:

WHEREAS, on October 1, 2024, Atmos Energy and Customer entered into the Service Agreement whereby Atmos Energy agreed to provide and Customer agreed to pay for certain natural gas services described in the Service Agreement; and

WHEREAS, on April 7, 2025, the Kentucky Public Service Commission approved the Service Agreement in Case No. 2024-00340 with an effective date of May 1, 2025; and

WHEREAS, Atmos Energy and Customer desire to amend the Service Agreement.

NOW THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Section “2. Natural Gas Service Type and Volume Levels” shall be amended by deleting the table

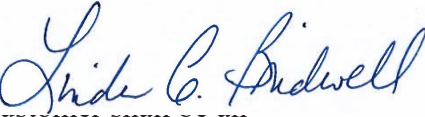

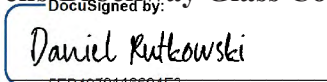
Interruptible Sales G-2 as defined by the Rate Schedule in the Tariff and as specified in the table above.”

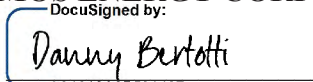

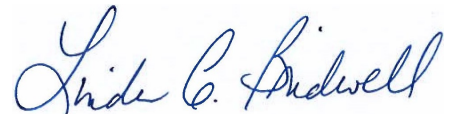
