# RATE RS RESIDENTIAL SERVICE

## APPLICABILITY

Applicable to firm natural gas service, which is comprised of commodity gas supply and local delivery service, required for all domestic purposes in private residences, single occupancy apartments, and common use areas of multioccupancy buildings, when supplied at one point of delivery where distribution mains are adjacent to the premises to be served.

### NET MONTHLY BILL

The Net Monthly Bill is determined as follows: All gas is billed in units of 100 cubic feet (CCF).

### 2. Applicable Riders

The following riders are applicable pursuant to the specific terms contained within each rider: Sheet No. 62, Rider DSMR, Demand Side Management Rate Sheet No. 65, Rider WNA, Weather Normalization Adjustment Rider Sheet No. 66, Rider PMM, Pipeline Modernization Mechanism Sheet No. 70, Rider GCA, Gas Cost Adjustment Clause

The "Customer Charge" shown above shall be the minimum amount billed each month. When bills are rendered less frequently than monthly the time related units such as cubic feet blocks, minimum or other charges, will be billed in accordance with the number of billing months in the meter reading interval.

#### LATE PAYMENT CHARGE

Payment of the Net Monthly Bill must be received in the Company's office within twenty-one (21) days from the date the bill is mailed by the Company. When not so paid, the Gross Monthly Bill, which is the Net Monthly Bill plus 2.3%, is due and payable. Customers who receive a pledge for or notice of low income assistance from an authorized agency, or another public or charitable source, will not be assessed or required to pay a late payment charge for the current bill for which the pledge or notice is received. An authorized agency is an organization in Kentucky that administers federal Low-Income Home Energy Assistance Programs and/or the Home Energy Assistance Programs offered by
