RULES AND REGULATIONS

SCHEDULE OF SPECIAL SERVICE CHARGES

The following charges for special services shall be made:

1. Service Connection Charge: A charge of \$ 15.00 shall be made for all service reconnections made during regular working hours, except that there shall be no connection charges made for service on the original installation of facilities. If service is reconnected other than during regular working hours, the charge shall be \$ 20.00.
2. Delinquent Service Charge: A charge of ten (10%) per cent of the delinquent bill shall be charged if the bill is not paid by the 25th day of the month.
3. Bad Checks: A service charge of \$8.00 will be charged on all bad checks.

Meter Test Request: Upon request and payment of \$20.00 a customer may have his meter tested provided request by the customer is not more frequent than once each twelve months. If such test shows the meter to be more than two percent fast, a refund of the \$20.00 charge shall be made and the bill adjusted accordingly. If the meter is found be running more than 2% slow the meter test charge will not be refunded, but the customer's bill will be recalculated and the amount due collected.
