**Re: Electronic Application of Louisville Gas and Electric Company for an Adjustment of its Electric and Gas Rates and Approval of Certain Regulatory and Accounting Treatments Case No. 2025-00114**

Dear Mr. Tummonds:

This letter is to notify you that on May 30, 2025, Louisville Gas and Electric Company (“LG&E”) filed an application for approval of adjustments to its gas and electric rates, terms, and conditions with the Kentucky Public Service Commission (“Commission”). On October 20, 2025, LG&E filed a Stipulation and Recommendation with the Commission. On February 16, 2026, after evidentiary hearings, the Commission issued an Order approving the Stipulation with modifications.

LG&E and Kentucky Utilities Company (“KU”), on behalf of their Electric Generation Businesses, receive natural gas sales and transportation service under a special contract for their Mill Creek facilities.

The revisions applicable to gas service under the special contract with service rendered on and after February 16, 2026, are set forth below:

A portion of the special contract for service to the Mill Creek facility incorporates by reference sales service provided under LG&E’s Firm Industrial Gas Rate IGS. The Sales Customer Charge for the Firm Industrial Gas Rate IGS will increase to from \$24.64 to \$29.69 per day. The special contract for service to the Mill Creek facility will increase its Monthly Sales Customer Charge from \$750.00 to \$850.00. The Demand Charge will increase from \$10.8900 to \$12.0400 per Mcf and the Distribution Charge will increase from \$0.3100 to \$0.3428 per Mcf.

All other provisions of your contract, not specifically mentioned herein, remain the same as those in effect to the date of the Commission’s Order of February 16, 2026, and all other Tariffs and Riders applicable to this contract will continue to apply.
