## A. The purpose of this modification is as follows:

The required staffing hours for the wastewater treatment plant are changing from 24 hours a day to normal business hours. The contractor recognizes that there may be situations, circumstances and/or events that necessitate that they have staff present for power grid testing exercises and for continuous staffing during extreme circumstances such as the Fort Knox military post being under Force Protection Condition level – Delta. As consideration for this change, if circumstances arise that are required by the Government to staff the wastewater treatment plant after normal business hours, the contractor shall provide qualified staff for the duration of the requested period when given 48-hours notice.

- **B.** The total obligation value remains the same at \$79,455,642.54.
- C. The total estimated contract value remains the same at \$179,229,816.46.
- **D.** All other Terms and Conditions of this contract remain unchanged and in full force and effect.
