





This tariff contains regulations and rates applicable for the furnishing of local exchange service, message toll telephone service, wide area telephone communications service, and for other general subscriber service, equipment and facilities associated with the above services offered by Logan Telephone Cooperative within this state. This tariff is on file with the Kentucky Public Service Commission.

Intrastate communication services are furnished through facilities provided by Salem Telephone Company for the transmission of intelligence by electrical impulse, principally by means of wire, radio, or a combination thereof.

Failure on the part of any subscriber to observe these rules and regulations, after due notice of such failure, automatically gives the Telephone Company the privilege to discontinue the furnishing of service.

This Tariff cancels and supersedes all other Tariffs of the Telephone Company issued and effective prior to the effective date of this Tariff.


