In case of a fire, charges for water usage shall be in accordance with Butler County Water System, Inc. Tariff Section II. F. Fire Protection. Charges for all other water usage shall be in accordance with prevailing Butler County Water System, Inc. rates for general service. Where a detector check valve with a bypass meter is used, the water usage shall be based on the combined volume of water used through both the detector check valve (estimated) and the bypass meter. All rates are subject to a 10 percent penalty if paid after due date.
