## RULES AND REGULATIONS

### 6.02.03 ELEVATED SERVICE AREA SURCHARGE

All customers shall pay a surcharge of \$0.56 per thousand gallons if water must be delivered at a higher elevation than the general pressure plane served by the Crescent Hill/Cardinal Hill System. (I)

### 6.03 WHOLESALE CUSTOMERS (Effective July 1, 2025)

Wholesale customers which purchase water for resale wherever situated shall be charged: \$2.23 per thousand gallons for all water purchased up to 150 million gallons per month, the elevated service area surcharge of \$0.56 per thousand gallons up to 150 million gallons, if applicable, and the service charge shall be charged in accordance with 6.03.01. The rates for any usage above 150 million gallons per month are per individual Wholesale contract. Wholesale customers may be charged a different service charge based upon the terms and conditions outlined in the Wholesale contracts. (I)

### DELAY CHARGE


In the event that payment for any charge is not made within twenty one (21) days from the billing date, the amount of the water bill shall be increased by 5% and the gross amount thus determined must be paid.

### TERM

The agreement shall have a term of 42 years from December 15, 2000, which term shall automatically extend for one additional year at each anniversary. Either party may give notice to the other party prior to the anniversary that the term shall not be automatically extended.
