ORDER

On February 23, 2005, Auxier Water Company ("Auxier") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. 807 KAR 5:067.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Auxier purchases water from Prestonsburg City's Utilities Commission ("Prestonsburg").
- 2. Prestonsburg notified Auxier that effective with its February 1, 2005 billing its wholesale water rates would increase by 2.2 percent over its current declining block rates. Auxier proposes to increase the water rates to its customers effective February 11, 2005.
- 3. During the 12 months ending December 31, 2004, Auxier purchased 75,352,000 gallons of water and sold 65,133,000 gallons. The increase in the cost of purchased water is \$4,054.44, resulting in a purchased water adjustment of \$0.0622 per 1,000 gallons.
- 4. The purchased water adjustment of \$0.0622 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The proposed rates by Auxier are accepted.

2. The purchased water adjustment of \$0.0622 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after the date of this Order.

3. Within 20 days of the date of this Order, Auxier shall file with the Commission revised tariff sheets showing the rates approved herein.
