On January 11, 2000, Sandy Valley Water District ("Sandy Valley") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Sandy Valley purchases its water from the city of Pikeville, Kentucky ("Pikeville"), and the city of Prestonsburg, Kentucky ("Prestonsburg").
- 2. Pikeville increased its wholesale water rate charged to Sandy Valley from \$1.38 per thousand gallons to \$1.69 per thousand gallons, effective January 1, 2000, to be reflected on the February 2000 bill.
- 3. During the 12 months ending November 1999, Sandy Valley purchased 179,938,000 gallons of water from Pikeville and 65,119,000 gallons from Prestonsburg, while having sold 194,290,000 gallons.
- 4. The increase in the cost of purchased water is \$67,890, resulting in a purchased water adjustment of 35 cents per 1,000 gallons of water. Based on a monthly usage of 5,000 gallons, the average residential bill of a Sandy Valley customer would increase \$1.75, from \$19.99 to \$21.74, or 8.75 percent.
  - 5. Sandy Valley's calculations are correct and should be approved.

6. The purchased water adjustment of 35 cents per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and should be approved.

## IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of 35 cents per 1,000 gallons and the rates in Appendix A are approved for bills issued on and after February 1, 2000.
- 2. Within 30 days from the date of this Order, Big Sandy shall file a copy of its updated tariff showing its new rates.
