

AMENDMENT TO WATER PURCHASE AGREEMENT

THIS AMENDMENT TO WATER PURCHASE AGREEMENT ("Amendment"), made and entered into on this 13th day of Jan 2026, by and between the **CITY OF SCOTTSVILLE**, a municipal corporation organized and existing under the laws of the Commonwealth of Kentucky and the **ALLEN COUNTY WATER DISTRICT**, a water district organized and existing under the laws of the Commonwealth of Kentucky.

WHEREAS, because of conditions in its distribution system, there are instances where it is advantageous for the City of Scottsville to purchase water from the Allen County Water District as it is most efficient from an operational standpoint for the Allen County Water District to supply certain customers of the City of Scottsville; and

WHEREAS, the City of Scottsville and the Allen County Water District desire that the purchase price of water sold by the Allen County Water District in these instances match the purchase price of water set in the Water Purchase Agreement between the City of Scottsville and the Allen County Water District;


WHEREAS, Seller and Purchaser desire to amend the Agreement between them as set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency, and adequacy of which are hereby acknowledged, a new Paragraph designated as Paragraph B(1)(b) is added to the Agreement to the parties which states as follows:

The purchase price for water sold by the Allen County Water District to the City of Scottsville is Four Dollars and Thirty-One Cents (\$4.31) per One Thousand (1,000) gallons.

Except as specifically amended by this Amendment, the Purchase Agreement originally entered into by the parties shall remain in full force and effect in accordance with its terms. The terms of this Amendment shall be incorporated into and made a part of the Purchase Agreement. To the extent any terms or provisions of this Amendment conflict with the terms and provisions of the Purchase Agreement, the terms and provisions of this Amendment shall control.
