At the time of each future rate recalculation SELLER will no PURCHASER of the increase or decrease in SELLER'S per 1,000 gallon purchase price of water and any such incre or decrease shall be added to the rate charged to FURCHASER, without increase or diminution, for the month in wh the recalculation is finalized and subsequent months until the next recalculation.
