The affiant, Charles Thomas Meade, states that he is president of Johnson County Gas Company, Inc. and has held that position since the date of incorporation and that the Johnson County Gas Company, Inc. purchased Fletcher Gap Gas Company in the spring of 1969 and at that time, the Fletcher Gap Gas Company operated a gas system in the community of Hager Hill and East Point in Johnson County, Kentucky. This system had been in operation for approximately ten (10) years at the time of purchase and had been originally installed and operated to the time of purchase by M. D. Bailey. This system had gradually grown as the population increased so that at the time of purchase the system contained approximately one hundred and twenty (120) meters. The Fletcher Gap Gas Company and the Johnson County Gas Company, Inc. have continually charged the same rate on gas sold in this system since it was first placed in operation and this is a minimum charge of Two Dollars (\$2.00), a minimum charge of Two Dollars and Fifty Cents (\$2.59) for two (2) MCF, and Seventy-Five Cents (\$.75) per each additional MCF above the Two Dollars and Fifty Cents (\$2.50). The affiant further states that a classification of service or adoption notice is being filed with this affidavit.
