**RULES AND REGULATIONS**

I. Rules and Regulations for the Government of gas utilities which may be adopted by the Public Service Commission of Kentucky, and all amendments thereto and modifications thereof which may be made by said Commission.

II.

1. The Company adopts the rules and regulations as prescribed by the Public Service Commission of Kentucky relative to the regulations of rates and services of Utilities operating in the State of Kentucky.

2. The Company shall furnish adequate, efficient and reasonable service, and may establish reasonable rules governing the conduct of its business and the conditions under which it shall be required to render service. Additions to existing facilities are to be made at the discretion of the Company. The Company shall not be liable for failure to render service until notified thereof and unless the reason for failure to render services was caused by its own negligence.

3. The rates adopted by the Company were "Issued by Authority of an Order of the Public Service Commission of Kentucky in Case No. 3703, dated July 11, 1960."

4. Rates are subject to purchased gas adjustment clause as ordered in case No. 3703, dated July 11, 1960.

APPLICABLE:

The tariff applies to users of natural gas in the city of Pineville, Kentucky and in Bell County North of the City of Pineville, Kentucky.

AVAILABILITY OF SERVICE:

Available for general domestic, Public Authority and Commercial service.

RATES:

Domestic and Public Authority

First	3,000 cu. ft. used per mo.	\$3.40 Minimum Charge.	
Next	2,000 cu. ft. used per mo.	.10 per 1,000 cu. ft.	(I)
Next	5,000 cu. ft. used per mo.	1.05 per 1,000 cu. ft.	
Next	5,000 cu. ft. used per mo.	.99 per 1,000 cu. ft.	
All over	15,000 cu. ft. used per mo.	.87 per 1,000 cu. ft.	

Minimum charge shall be \$3.40 per month for which 3,000 cu. ft. of gas is allowed.

Commercial Service

First	70,000 cu. ft. used per mo.	\$ .78 per 1,000 cu. ft.
Next	80,000 cu. ft. used per mo.	.71 per 1,000 cu. ft.
All over	150,000 cu. ft. used per mo.	.68 per 1,000 cu. ft.

The above rates are net. If payment is not made by the 10th of the month following date of service, 10% will be added to the face of the bill.

Commercial Service applies to only Laundry and Dry Cleaning Establishments.
