- 5. The City accordingly wishes to withdraw its CLEC application, to relinquish its CLEC authority to operate as a CLEC, and to be released from any further responsibility for filings to this Commission that may be required of a CLEC in Kentucky.

WHEREFORE, for the reasons stated above, the City requests that the Commission allow the City to withdraw its application and thereby relinquish the City's authority to operate as a CLEC and to release the City from any further responsibility for filings that may be required of a CLEC in Kentucky. The City further requests that the Commission enter all necessary Orders and/or docket annotations necessary to effect the requested actions.
