Special Rules: (Cont'd)

2. Continued

The charge, also, applies if service is reinstalled after it has been disconnected for non-payment of bills, violation of the company's or Commission's Rules and regulations, and the customer has qualified for and requested the service to be reconnected.

3. Service to mobile homes: An applicant requesting service to a trailer may be required to pay all cost of connecting service incidental to the installation of service except for the meter and regulator. In addition to this a deposit of \$20.00 will be required to secure payment of bill. All fees to be paid in advance. If service is provided 12 months at the same location any installation fees in excess of the \$20.00 deposit will be refunded.
