



1. These rules and regulations are in addition to the rules of the Kentucky Public Service Commission.
2. Any resident or business of Bandana Water District is eligible for water service from the District, providing a water main is within 100 feet of his property line. C

3. Water service will be terminated within 24 hours after receiving a written request from the customer requesting discontinuance.
4. All applications for service to rental property shall be accompanied by a \$10 deposit to assure payment of bill, except applications for service to trailers, which shall be \$15.
5. All applications for service shall be accompanied by a tap-on fee in the following amounts:



6. The customer shall be responsible for all plumbing installed on his property beginning at the outlet side of the water, said installation to be in accordance with the rules and regulations of the Kentucky Department of Health.
7. No customer shall resell water except under the terms of a special contract executed with the District.
8. All services shall be metered.
9. The District will not furnish free water to any person for any purpose.
