

RULES AND REGULATIONS

BARNESBURG WATER ASSOCIATION, INC.

Resolution of the Barnesburg Water Association, Inc. of Pulaski County, Kentucky, Establishing Rates and Charges for the use of and the services rendered by the Association Waterworks System, and providing for the collection of such rates and charges.

WHEREAS, the Commission of the Barnesburg Water Association, Inc., of Pulaski County, Kentucky, has heretofore determined that the promotion and preservation of the public health, safety and general welfare of said Association and of all of its citizens and inhabitants require the construction and installation of a new Association waterworks systems, and

WHEREAS, the Association is by concurrent proceedings providing for the issuance of its Waterworks Revenue Bonds for the purpose of defraying the costs (not otherwise provided) of constructing said system in the manner provided by KRS Chapters 74 and 106, and

WHEREAS, in and by said statutes it is required that rates or charges for services of the Association waterworks system be prescribed and maintained so as to provide for the payment of interest upon and principal of said Bonds as the same become due, and also to pay operating and maintenance cost, as well as to create a depreciation fund, and

WHEREAS, it is necessary at this time that a schedule of rates for water service be prescribed and that provision be made for the collection thereof,

RULES AND REGULATIONS

NOW, THEREFORE, THE COMMISSION OF THE BARNESBURG WATER ASSOCIATION, INC., OF PULASKI COUNTY, KENTUCKY, DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. WATER CONNECTION CHARGES

Waterworks connection charges are hereby established and shall be exacted for each connection with municipal waterworks system, with a charge of \$300.00 being made for water connection, and with lower connection charges of \$250.00 being made for those properties owned by persons applying for connections and paying the applicable charges prior to the date on which construction of the new waterworks system commences.

Section 2. BASIS MONTHLY WATER RATES

There shall be and there are hereby established from and after the effective date of this Resolution, basis monthly rates or charges for the water supplied by the waterworks system of the Association as follows:

A. Minimum Water Rate

The minimum water bill shall be \$7.25 per month, and each water customer shall be entitled to 1,500 gallons (or less) of water in each month for such minimum charge.

B. Meter Rates for Water Usage in Addition to Minimum Charge

Subject to the minimum water rate specified above, the following metered charges shall be made for each 100 gallons or less of water consumption per month to customers of all size connections:

RATES MONTHLY:

First 1,500 gallons	\$7.25 (Minimum bill)
Next 1,500 gallons	2.75 per 1,000 gallons
Next 2,000 gallons	2.50 per 1,000 gallons
Over 5,000 gallons	2.25 per 1,000 gallons

Section 3. METER DEPOSITS

In addition to connection charges as aforesaid, all customers may be required to pay a meter deposit of 2/12 of the customer's estimated annual bill to the Association for water service before such customers shall be entitled to such service. Such deposit, less any unpaid charges, shall be refunded to such customer, his heirs or assigns, whenever such customer notifies the Association legally to disconnect or terminate service to such customer. Interest of 6% per annum will be paid on deposits.

Section 4. BILLING; COLLECTION ; PENALTIES

The rates or charges aforesaid shall be billed monthly, on statements which shall be issued on or about the first of each month, and all bills which shall be issued on or about the first of each month, and all bills for such service shall be considered due and payable ten days after the date of issue. If a bill is not paid within ten days after such date of issue, such bill shall be considered delinquent, and there shall be imposed a penalty on each bill not so paid, in an amount equal to ten percent (10%) of the charges (~~other than sales tax~~) shown on the face amount of such delinquent bill. The Association may serve a customer written notice of ~~public service commission~~ **PUBLIC SERVICE COMMISSION OF KENTUCKY** effective. If such bill is not paid within ten days after the mailing of such notice, the Association may disconnect

the water service of such customer without further notice. If water service is disconnected by the Association by reason of delinquency in the payment of any water bill, reconnection of such service shall not be made until the user pays all charges and penalties owed, plus the amount of \$10.00 as a disconnection and reconnection charge. In case this is a tenant, the property owner or future tenant will not be penalized in any way. If any deadline date falls on a Sunday or legal holiday, such deadline shall not expire until the next secular day thereafter.

Section 5. CODE OF BY-LAWS INCORPORATED BY REFERENCE

The Commission has concurrently herewith adopted a detailed Code of By-Laws prescribing rules and regulation for the operation of the waterworks system of the Association. Such Code is incorporated in the Rate Resolution by reference and is made a part hereof. Copies of said Code of By-Laws are on file at the office of the Secretary of the Association, where same may be examined by any interested party.

Section 6. SEVERABILITY

If any clause, provision, paragraph or section of this Resolution be ruled void and unenforceable by any court of competent jurisdiction, the remainder hereof is intended to be adopted and shall be in full force and effect notwithstanding.
