RULES AND REGULATIONS

The following rules and regulations are subject to change by the Water District Commissioners at any time subject to the approval by the Public Service Commission.

1. Rates shall be billed by the District in accordance with the Tarriff issued by the Kentucky Public Service Commission.
2. Meters shall be read, recorded and billed once a month. Cards posted by date of meter reading.
3. Past due accounts: Persons will be notified on third month by "Past Due Notice" stamped in RED on Billing card, that service will be discontinued by the 10th. of that particular month if account is not paid by that date.
4. Estimated meter readings will be so marked on the billing cards.
5. Meters pulled for reason of non-payment of account and/or at the request of the customer, will be charged a \$15.00 meter service for re-installation. (See attachment for justification).
6. Bills are due and payable by the 10th. of each month, with a 10% penalty for payment after the 10th.
7. Posting of permanent billing cards will be done by the "Stub" returned by the customer with payment. If for some reason the stub is not returned to the District, one will be made when payment is received, marked "COPY".
8. In the event a customer requests his meter re-read, and/or pulled and checked for correct metering, and such necessitates a trip to his residence or place of business, and if the meter reading was correct and/or if the questioned meter was measuring properly, a charge of \$10.00 will be made to said customer for expense of this service. If error is found, no charge will be made. (See attachment for justification)
9. Rates of the District will be published in the local paper at least once a year for customer information.
10. A rule to charge for water used by either of the Fire Departments operating from our System is pending, and action on such will not be taken until having advice and approval from the Public Service Commission.



2" service	300.00

After completion of the Project, the connection fee is to be \$150.00 for 5/8" service; for larger services the connection fees shall be the actual cost of the meter plus cost of installment.

Penalty: 10% penalty if bills are not paid by the 10th, of the month.
