This rate is applicable in an area lying south and east of Barbourville, Kentucky in Knox County and north of the Bell County line along U.S. Highway 25E, State Highways 930 and 225 and including the communities of Bimble, Baughman, Flat Lick, Artemus and Himyar.

Availability of Service:

Available for General Domestic, Commercial and Industrial service to Customers on existing mains or secondary lines of the Utility's water distribution system.
