RULES AND REGULATIONS

The following rules and regulations are subject to change by the Water District Commissioners at any time subject to approval by the Public Service Commission.

1. Meters will be read on the 20th. of the month or as soon there after as possible.
2. Bills will be dated and mailed the last day of the month. Said bills will contain a rate schedule, penalty date and cut off time if they are not paid also a service charge for turning water back on for nonpayment
3. All meters will be placed on the owners property and to service lines attached to district mains.
4. Complaints may be made to the person reading meters and doing repair and upkeep work or to any one of the three District Commissioners.
5. The principal place of business of the District will be in an office maintained at the home of the secretary of the Commissioners, T.C.Gregory.
6. Bills may be paid at the above mentioned office or mailed to Hima, Ky. 40951 or Manchester, Ky. 40962 R#4 Box 102.
7. Rates are for the amounts fo water used and any applicable sales tax shall be added to each bill as a separate charge.
8. Dual users or multiple connections are prohibited.
