

RULES AND REGULATIONS

1. These rules and regulations are in addition to the rules of the Kentucky Public Service Commission.
2. Any resident of Lone Oak Water District is eligible for water service from the district.
3. Water service will be terminated immediately upon request from the customer requesting discontinuance.
4. All applications for service shall sign a Consumers Application Card. No deposit required.
5. Meters are read monthly. All bills are due and payable on the 8th of the month.
6. A 10% collection charge is added if not paid on or before the 18th of the month.
7. Notices are sent to consumers whose bill remains unpaid on the first of the following month from date of bill stating the date services will be discontinued.
8. Services are discontinued on all unpaid bills on the 9th or 10th of the month.
9. To reconnect, the consumer must pay the bill plus a \$1.00 service charge.
10. A charge of \$95.00 is made for ^{Ordinary} meter installations, the meter is installed on the consumers property. Meters larger than 3/4", cost plus.
11. The consumer installs the line from the meter to the building at his own expense.
12. Upon a request from the consumer the meter will be brought into the shop and tested; if the test proves the meter to be within 2% of perfect, either fast or slow, a consumer is charged \$3.00. If not, necessary adjustments are made.

General Service

RATE
PER UNIT

Applicable: Within the service area of Lone Oak Water District

Availability: To domestic, farm, commercial and industrial customers

Rates:

First 2,500 Gallons of water used per month (Minimum Bill)	3.00
Next 7,500 Gallons of water used per month per 1,000 Gallons	.95
Next 10,000 Gallons of water used per month per 1,000 Gallons	.70
Next 30,000 Gallons of water used per month per 1,000 Gallons	.60
Next 50,000 Gallons of water used per month per 1,000 gallons	.40
All over 100,000 of water used per month per 1,000 Gallons	.35

Minimum Charge: Shall be \$3.00 for which 2,500 gallons or less of water may be used.

Delayed Payment Charge: If bills are not paid by the 18th of the month, 10% of water bill will be added to the bill.

Term: of service is on a monthly basis.
