RULES AND REGULATIONS

1. ANY RESIDENT OF STRINGTOWN IS ELIGIBLE FOR WATER SERVICE FROM STRINGTOWN WATER DISTRICT.
2. WATER SERVICE WILL BE TERMINATED WITHIN 24 HOURS AFTER REQUEST FROM CUSTOMER.
3. ALL APPLICATIONS FOR SERVICE SHALL BE ACCOMPANIED BY A \$20.00 DEPOSIT, WHICH WILL BE RETURNED UPON SETTLEMENT OF FINAL BILL AFTER TERMINATION OF SERVICE. Interest will be paid at the rate earned but at no time will the rate exceed 6 percent.
4. THE CUSTOMER SHALL INSTALL AND MAINTAIN ALL SERVICE LINES FROM THEIR METER.
5. PENALTIES---BILLS ARE DUE ON OR BEFORE THE 15th OF THE MONTH. AFTER THIS DATE A 10% PENALTY WILL BE ADDED. IF NOT PAID ON OR BEFORE THE 15th OF THE FOLLOWING MONTH, SERVICE WILL BE DISCONNECTED. ( THE ABOVE STATEMENT IS PRINTED ON BILLS)
6. SERVICE DISCONTINUED FOR NON-PAYMENT SHALL BE CHARGED A \$20.00 RECONNECTION FEE.
