On behalf of our client, Time Warner Cable Information Services (Kentucky), LLC ("TWCIS"), and pursuant to the Commission's regulations, we submit an original and 10 copies of the attached (1) Amendment to its Certificate of Authority, and (2) Certificate of Assumed Name, both of which were issued by the Secretary of State of the Commonwealth of Kentucky. These documents are intended to supplement the attachments to TWCIS's Notice of Intent to provide intrastate telecommunications services, filed with this Commission on March 10, 2006.
