
RE: Westel-Milwaukee Company, Inc.'s Change in Form to Become Westel-Milwaukee Company, LLC

Specifically, Westel-Milwaukee Company, Inc. merged with Westel Milwaukee Merger Corp., a Georgia corporation. Westel Milwaukee Merger Corp. changed its name to Westel-Milwaukee Company, Inc. and elected under Georgia law to become a limited liability company named Westel-Milwaukee Company, LLC. Although this change in business form does not appear to constitute a change in ownership or control, as those terms are used in KRS 278.020(4) and (5), Westel-Milwaukee Company LLC nevertheless is notifying the Commission and complying with its Order dated January 8, 1998 in Administrative Case No. 370.



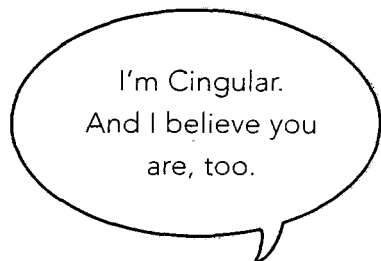

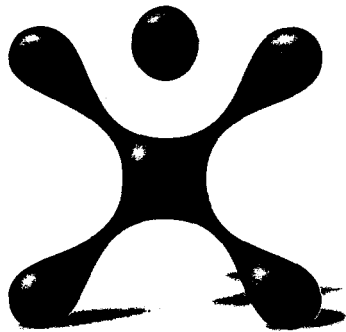
